APPLICANT’S CHECK LIST

- 1) o Review CE-4 Specifications (wire/cable) and/or CE-8 Specifications (conduits/pipelines).
- 2) o Proper name and mailing address of Licensee.
- 3) o Application fee.
- 4) o Location data (CE-4, Plate I or CE-8, Plate II)
- 5) o Plan and Profile drawings (8½” x 11”, 8½” x 14” or 11” x 17” size only).
- 6) o Pipe Data Sheet (CE-8, Plate I).
- 7) o Depth of bury (CE-8, Plate III).
- 8) o Method of installation (no alternatives).
- 9) o Distance from face of launching and receiving pits (CE-8, Plate III).
- 10) o Location of Manholes and valves (CE-8, Plate IV)
- 11) o Size, voltage and type of :wires, cables or Fiber Optic Cables
- 12) o Wire/Cable vertical clearance from sag to top of rail (CE-4, Plate II).
- 13) o Distance from Poles to centerline of track (CE-4, Plate I).
- 14) o Pole configuration (CE-4, Plate II).
