

# **Contractor Training**

Includes Elements of Roadway Worker Protection Title 49 CFR Part 214, Subpart – C-D

Consolidated Rail Corporation (CONRAIL) requires that all personnel, working within CONRAIL right of way, participate in the CONRAIL Contractor Orientation or CONRAIL Roadway Worker Protection Training Program. These programs are designed to help personnel avoid putting themselves in a Position of Peril on our property. This is accomplished through basic training on how to stay safe and aware around live railroad tracks.

The Consolidated Rail Corporation (CONRAIL) training provider is National Railroad Safety Services, Inc. (NRSS).

This Contractor Orientation (CO) training session is 2 to 2-1/2 hours in duration and includes a 25 question multiple-choice exam. The Roadway Worker Protection training session is 4 to 4 1/2 hours in duration and includes a 50 question multiple-choice exam. Only participants passing this examination will be permitted on the property. A qualification Photo ID Training Badge will be issued to each participant after passing the exam and once payment has been received. The training is good for a period of twelve months. The issued badge must be carried at all times while working within CONRAIL right of way and presented on demand when and where required. If any individual on the property cannot produce a valid Photo ID Training badge, said person will not be allowed onto the property.

## **Training Options:**

- 1. Webinar: Certain technical requirements apply. Each workstation will need a computer with stable internet, two-way video (i.e. webcam), two-way audio (i.e. phone or computer mic & speakers), capability to display the presentation for everyone to clearly see, and capability to print and scan/fax testing documents.
- 2. At the Contractor's Facility or Rental Facility: Additional charges include trainer costs per the fee schedule below.
- 3. NRSS Facility: CA, Sacramento / IL, Chicago / MD, Frederick / NY, Albany / OH, Cincinnati / TX, Arlington

#### **Scheduling:**

- Scheduling is on a first come, first served basis and is as needed.
- Classes may be conducted between the hours of 8:00am 5:00pm Eastern Time, M-F.
- Three-business days (72 hours) advanced notice is recommended for scheduling.
- When scheduling, contractor will be given a training request form.
- Training request form must be completed and submitted for each company in attendance prior to training date.
- A Headshot must be submitted for each student prior to training date.
  - Headshots are to be taken against a white wall with all hats, sunglasses, etc. removed from face.
  - Headshots are to be labeled appropriately to identify each student.
- If any participants require special accommodations, please make this request at the time of scheduling.
